

Notice on the meeting of the Mayor with municipal directors

## Municipal executive starts the drafting of the Regulation on limited and prohibited actions at the Historic Centre

15 March 2013, Prizren

Proceeding from the "Online Transparency of Prizren Municipality" project, EC Ma Ndryshe has partaken in the subsequent meeting of the Mayor, Mr. Ramadan Muja, with the municipal directors, in which a number of decisions were rendered.

According to the Law No. 04/7-66 on the Historic Centre of Prizren, Prizren Municipality is obliged, within the provisions of this Law, to draw up a regulation on the limited and prohibited activities within the Historic Centre of Prizren.

As for this task, Prizren municipal government has established a seven-member committee consisted of different departments, which will draw up this regulation. This committee will be composed of two members from the Directorate of Urbanism and Spatial Planning, one each from the Directorate of Public Services, Directorate of Culture, Directorate of Tourism, Directorate of Inspections and one member from the Institute for Protection of Cultural Monuments as well.

At the request of the Directorate of Urbanism, the local executive has allowed the announcement of the tender for the design and restoration of Ymer Prizreni's object/house, as well as allowing funds for payment of the consent given from KEK (*Kosovo Energy Corporation*) to Europa Complex and connecting the electricity to the facility.

Requests of the Directorate of Public Services have been approved for the announcements of the tenders for construction of several local streets and guard rails with shared contribution, as at "Hysni Morina 1" Street, guard rail at Landovica village and local streets in Hoçë e Qytetit village, as well as the announcement of the tender for the construction of a sewage system in Arbana neighbourhood, where the latter amounts to about 60,000.

There was also passed the request for a decision on the appointment of the Committee responsible for reviewing applications and preparation of the issuance of the Municipal Environmental Permits, as well as the authorization of an official for affixing his/her signature on these permits that will be aimed at enforcing the lawfulness and environmental protection.

The proposal of the Directorate of Health has also been passed for conducting bacteriological and chemical analysis of drinking water in 40 villages of Prizren municipality.

Local executive has approved the requests of the Directorate of Tourism and Economic Development on allowing the announcement of the tender for the maintenance of an open archaeological museum, as well as the announcement of the tender for the design and printing of promotional materials that will be used to attract foreign visitors, easier accessibility to the touristic points, etc.

Permission was also granted to the Directorate of Culture, Youth and Sport to allow the announcement of the tender for the assessment and project design of the roof of the House of Culture in Zhur village, publication of the monograph "Feniksët e Lirisë-15", financial support to the Association of Physical Education Teachers in Prizren for participation in the world championship of school basketball which is held in Cyprus.

At this meeting, the municipal government, at the request of the Directorate of Agriculture and Rural Development, has allowed the announcement of the tender for supply of 60 milking machines for farmers (estimated  $\pounds$ 25,000), the opening of the tender for disinfection, fumigation and deratization in the city of Prizren (estimated  $\pounds$ 30,000).

EC Ma Ndryshe's project for transparency monitoring of the executive branch shall continue on publicizing monitoring findings through regular press releases and project's website where the findings are posted directly from the monitoring staff. By now, all the monitoring findings, including regular press releases and other information relative to local government of Prizren, are published on regular basis on the project's website: <u>www.online-transparency.org</u>.
