**Notice on the meeting of the Mayor with the heads of municipal departments
Municipality allocates 10,000 EUR for “Nine Eleven” Film Festival**

17 July 2013, Prizren

Proceeding from the “Online Transparency of Prizren Municipality” project, EC Ma Ndryshe has partaken at the following meeting of the Mayor of Municipality, Mr. Ramadan Muja, with the municipal directors, in which a number of decisions were rendered.

At the request of the Department of Culture, Youth and Sport local executive has rendered a decision for supporting of traditional film festival “9/11 – Nine Eleven Dedication Festival” with EUR 10,000, a festival which has so far been held in Pristina. The decision was not unanimous since certain officials of the municipal government voted against. The decision was also followed with discussions whereby it was requested to confirm support for “Dokufest” Film Festival that is traditionally held in Prizren. Although the allocation of funds for “Dokufest” Film Festival was not scheduled in the agenda of this meeting, this point has been reviewed thereby Prizren’s local government has decided to support “Dokufest” with 15,000 EUR. In addition, the Mayor emphasized that, apart of 15,000 EUR, municipality will also provide logistical support to “Dokufest” by offering transportation services, sound, equipment, etc.

At this meeting another proposal of the DCYS has also been passed for the organization of the swimming course by the Association for Culture, Youth and Sports “Arena”, financial support amounting 4,000 EUR.

Municipal government approved the proposal of the Department of Public Service for allowing the announcement of the tender for construction with concrete elements of several local streets (Hajzeraj neighbourhood in Nashec village; Oso Kuka, Meriman Jakupi and Mbreti Gent streets in Prizren) and a sewer system at Emin Abazi Street of Prizren with shared funding.

Request of the Department of Labour and Social Welfare for allowing the tender announcement for the regulation of environmental infrastructure around the collective dwellings of the families of martyrs, war invalids and social cases has been approved as well.

Green light has been granted also to the proposal of the Department of Health for providing financial support to 19 patients ailing from severe illnesses.

Also, the proposal of the Department of Agriculture and Rural Development on allowing the announcement of the tender for subsidizing farmers of Prizren municipality with wheat seeds has passed at this meeting.

EC Ma Ndryshe’s project for transparency monitoring of the executive branch shall continue on publicizing monitoring findings through regular press releases and project’s website where the findings are posted directly from the monitoring staff. By now, all the monitoring findings, including regular press releases and other information relative to local government of Prizren, are published regularly on the project’s website: www.online-transparency.org.
