## **Report on the meeting of the mayor with the municipal directors** Local government aims at improving collection of its own-source revenues

EC Ma Ndryshe, within the "Online Transparency of Prizren Municipality" project, has taken part this week's meeting of the mayor, Mr. Ramadan Muja, with the municipal directors, in which a number of decisions were rendered. Because these decisions are closely related to public interest, EC Ma Ndryshe, in the interest of increasing the transparency of the local executive branch, this time onward shall publish reports on the meetings of municipal government, i.e. adopted decisions.

Municipal executive of Prizren, in the recent meeting has passed conclusions proposed by the Directorate of Economy and Finance (*hereinafter* DEF) for allowing the announcement of the tender for implementation of the project "Research on the Identification of Problems and Prospects for Improving of Collection of Own-source Revenues in Prizren Municipality." According to responsible municipal officials, the goal of the project is to identify problems in the collection of property tax charges and municipal taxes. It has also been approved subsidiary conclusion proposed from DEF for the announcement of the tender for delivery of the training for the staff related with the improvement of municipal services (pre-calculated  $\in$ 9,950), as well as the decision for the payment of special services and works for the municipal administration of Prizren Municipality (in amount of  $\in$  20,000).

Municipal government has adopted the proposals of the Directorate of Public Services allowing the announcement of the tender for the collection of decorative tree saplings in the city (pre-calculated around 10,000  $\textcircled$ ), then for the tender announcement for standard fencing of green oasis, squares, obelisks and so forth, from the category of capital projects (the amount of  $\pounds$ 10,000). At the same time it was allowed the announcement of the tender for the construction of several local roads with financial participation of citizens ("Bujana" street and "Zekaj" neighbourhood street in Korisha village).

The Board of Directors has also approved the proposal of the Directorate of Administration on allowing the announcement of the tender for supply with the material for the maintenance of the electric network, water supply and sanitation, as well as for the central heating system of the municipal building. During this meeting were rendered some other decisions of technical character. A decision was also taken to support the activities on the occasion of marking the September  $15^{\text{th}}$  – The Martyrs Day and arranging a traditional lunch for the family members of the martyrs.
