Notice on the meeting of the Mayor with directors of Municipality

Local government builds road infrastructure with shared funding

3 July 2013, Prizren

Proceeding from the "Online Transparency of Prizren Municipality" project, EC Ma Ndryshe has partaken in the meeting of the Mayor, Mr. Ramadan Muja, with the municipal directors, in which a number of decisions were rendered.

Municipal government of Prizren, at the request of the Directorate of Public Services, has rendered a decision on the allowing the announcement of tenders for construction of roads/streets with concrete elements and construction of the sewage system with the system of shared funding for creation of better infrastructure for work and life for the residents of some city neighbourhoods and villages of the municipality.

Local executive has allowed the funds for the construction of canalization for "Raguza", "Hajdar Shala" and "Skender Latifi" streets in Prizren; construction of the road of Gutaj neighbourhood in Nashec village; construction of the local road in Jablanice/Jabllanicë village; construction of "Salajdin Berisha 3,4", "Beamir Memaj", "Emin Abazi-1" and "Elbasani-1" streets; construction of the street in Badallaj neighbourhood of Prizren and local roads in Gjonaj and Kushnin villages of Has district.

Also, based on the request of the residents of Billushë village for construction of local roads, the board has allowed the announcement of a tender for construction of this project amounting about 50,000 Euros, funds allocated by the Directorate of Public Services according to the budgetary planning of the Municipality.

Furthermore, at this meeting a decision was taken to allow funds for construction of the bridge in Korishë village.

On the proposal of the Directorate of Urbanism, local executive has approved the requests made by this directorate regarding the announcement of the tender for drafting of two Urban Regulatory Plans – "Greenery with furniture and leisure" that is foreseen under the Urban Development Plan, which will include Arbana neighbourhood on the sides of the highway; and, secondly, the Urban Regulatory Plan "Lakuriqi Verior 2", where a high-rise construction is foreseen. This regulatory plan includes a part of Theranda/Suhareka (The so-called Fshati; *Eng: the Village*) that is bordered with the Light Industrial Zone and towards the PLSS "Lekë Dukagjini".

At this meeting, local government, by the proposal of the Office of Communities and Returns, has reviewed and unanimously allowed the announcement of tender for supply with construction materials for the renovation of housing of social cases among the communities.

The Directorate of Administration was given a green light for allowing the announcement of tenders for supply with materials for maintenance of the water supply, sewer and central heating systems in municipal facilities. Additionally, to the request of this directorate a decision was approved for the

imprint and incrustation of the new logos for the needs of the protocol, such as brass material, cutting and embossing the brass, abrasion of the material with acid, gilding the material and supply with strong paper material for storage boxes.

In this meeting, the executive had unanimously approved the requests for the official travel abroad for two officials of MDE and DLSW to Durrës of Albania, an official of the DTED in Macedonia, approval of the requests for permits and per diems, as well as for two officials from the Office of Returns and Communities for official travel in Serbia. For the latter, the municipality covers all the expenses.

Project of EC Ma Ndryshe for transparency oversight of the executive branch will continue on publicizing monitoring findings through regular press releases and project's website, where the findings will be posted directly by the monitors. So far, all the monitoring findings, including regular press releases and other information relative to local government of Prizren, are regularly published on the project's website: www.online-transparency.org.
