## Notice on the meeting of the Mayor with the municipal directors

Municipal government allocates €0,000 for demolition of structures built without a construction permit

13 February 2013, Prizren

EC Ma Ndryshe, within the "Online Transparency of Prizren Municipality" project, has partaken in the following meeting of the mayor, Mr. Ramadan Muja, with municipal directors, in which a number of decisions were rendered.

Municipal government of Prizren, at the request of the Directorate of Inspections, has rendered a decision to allow the announcement of a tender for selection of an economic operator who will execute decisions on demolition of structures built without a permit in the municipality of Prizren. Implementation includes a one-year period, namely for the year 2013, for which the Directorate of Inspections has estimated the amount of €0,000 for execution of the demolition works of structures built without a permit. Expected outcomes from execution of this decision, according to the proposal of the Directorate of Inspections, envisage: adherence to the urban planning, realization of constructions according to the standards set out and the increase of municipal budget.

Municipal government has also approved the proposals of the Directorate of Public Services for the announcement of the tenders for construction of local roads in Bregdri, Kojush, Krajk, Vërmicë and Romajë villages (pre-calculation €260,000); construction of a local road and sewer system in Randobravë village (€50,000); construction of a local road in Petrovë village (€0,000), as well as construction of Piranë-Reti, Dedaj-Rugovë and Krushë e Vogël-Piranë roads. It is also foreseen regulation of sidewalks in Arbana and the expanding and construction of the main road to Poslisht village and construction of sewer systems in Mazrek (€30,000) and Dobrusht villages (€40,000).

The proposals of the Directorate of Education have also been approved for the announcement of the tenders such as: construction of a sports field of "Lidhja e Prizrenit" Primary/Secondary Low School (PSLS) – (estimated €30,000); installation of a central heating system in PSLS "Heronjtë e Lumës" in Vërmicë village (€30,000); supply with consumable and construction materials for execution of practical learning for students of the Secondary Technical School "11 Marsi" in the amount of €20,000. The proposal for the announcement of the tender for the supply with school inventory for the year 2013, accounting about €37,750 from capital investments category, has been approved, as well as the construction of two classrooms for instruction – one in PSLS "Mushnikova/Musnikovo" and the second one in Drajciq/Drajcici village.

The requests of the Directorate of Administration were also approved, for allowing the announcement of the tenders for servicing the vehicles type Golf 6 and Caddy ( $\leq 10,000$ ), as well as for supply with consumable materials for the needs of the municipality in the amount of  $\leq 0,000$ .

Permission was also granted to the Directorate of Work and Social Welfare on the announcement of the tender for drafting the plan and construction of housing for the families of martyrs and war invalids of the KLA.

Board of Directors has also approved the requests of the Department of Tourism and Economic Development for restoration of a touristic road to Kabash Fortress and on the setting up of a committee which shall identify buildings (houses) in the Historic Centre of Prizren for facade treatment purposes.

EC Ma Ndryshe's project for transparency monitoring of the executive branch shall continue on publicizing monitoring findings through regular press releases and project's website where the findings are posted directly from the monitoring staff. By now, all the monitoring findings, including regular press releases and other information relative to local government of Prizren, are published on regular basis on the project's website: <a href="https://www.online-transparency.org">www.online-transparency.org</a>.
