## Notice on the meeting of the mayor with the municipal directors Draft-decision for Municipal Inspections foresees monetary penalties

27 February 2013, Prizren

EC Ma Ndryshe, within the "Online Transparency of Prizren Municipality" project has partaken in the following meeting of the mayor, Mr. Ramadan Muja, with the municipal directors, in which a number of decisions were rendered.

Prizren municipal government has approved the proposal of the Directorate of Inspections related to the draft-decision for Municipal Inspections. Within the draft-decision for Municipal Inspections of Prizren Municipality punitive measures were set out. Provisions of this draft-decision foresees the penalties in the amount from 500 to 2,500 EUR against a legal person committing minor offenses, in cases as: when failing to comply to the record or the decision of the municipal inspector; when preventing the inspector in discharging of his/her duty or when refusing to provide the inspector with information which he/she requires; with a fine in the amount from 100 to 250 EUR will be punished a responsible person if he/she fails to notify the municipal inspector on the execution of the measures ordered, and so forth. This draft-decision has been forwarded to the Policy and Finance Committee (PFC) and the Municipal Assembly for further approval.

Local executive has approved the requests of the Directorate of Work and Social Welfare for the expropriation of immovable property of former Solidarity housing in "Nëna Tereze" Street, where, after the expropriation, new housing complex will be built and those will be given to the families of martyrs, war invalids and to poverty-stricken families. It was also approved the request for allowing funds for the maintenance of the Temporary Collective Shelter "Farmakos" in Prizren that accommodates 22 families with a total of 103 persons.

Requests of the Directorate of Health have also been approved for purchasing medical equipments for the needs of healthcare services for the Main Family Medicine Centre, Family Medicine Centres and Health Houses, (estimated  $\epsilon$ 70,000), as well as the decision on the financial support for the realization of physicians' medical visiting in primary schools of Prizren Municipality for pupils of 1<sup>st</sup>, 5<sup>th</sup> and 9<sup>th</sup> grades (estimated  $\epsilon$ 7,000).

Permission has been given to the Directorate of Economy and Finance on the establishment of the Appeals Review Board for the appeals on the immovable property tax for the year 2013 according to the Law on Tax on Immovable Property No. 03/L-204.

At this meeting the requests of the Directorate of Tourism and Economic Development have also been approved related to the announcement of the tenders – 'Lighting of the Monumental Structures' (estimated €20,000) and for 'Project design for Construction of Touristic Information Centre of Prizren Municipality'.

The Directorate of Public Services was allowed for the tender announcement on the rearrangement of metal fences and environmental furniture in green areas; planting of decorative tree saplings in the city, as well as granting of funds for the construction of sewer system in "Ali P. Tepelena 1" Street.

Local executive has unanimously approved the proposal of the Directorate of Agriculture and Rural Development for the appointment of members of Municipal Committee for registration of agricultural assets for the year 2013 that will provide real agricultural data for the needs of central and municipal governments.

EC Ma Ndryshe's project for transparency monitoring of the executive branch shall continue on publicizing monitoring findings through regular press releases and project's website where the findings are posted directly from the monitoring staff. By now, all the monitoring findings, including regular press releases and other information relative to local government of Prizren, are published on regular basis on the project's website: www.online-transparency.org.
